Contract of Bailment

- Indian Contract Act
- A contract of bailment can be valid without consideration.
- **Gratuitous Bailment**: Bailment without any consideration.
- Non-Gratuitous Bailment: Bailment with consideration.
- The Bailor is bound to disclose the Bailee faults in the goods bailed-
- Of which the Bailor is aware
- and which materially interfere with the use of them
- or expose the Bailee to extraordinary risk







Contract of Bailment

- And if it does not make such disclosure, he is responsible for damage arising to the Bailee directly from such faults
- If the goods are bailed for hire, the bailor is responsible for any damage whether he was aware of the existence of such faults in the goods bailed or not.
- Taking care of goods
- Mixing goods or expenses with consent
- Mixing goods or expenses without consent
- Mixing goods without consent which are not possible to separate







Duties of the Bailee with regards to Goods

- It is the duty of the Bailee to return the goods bailed as soon as the time for which they were bailed has expired.
- The Bailee is responsible to the bailor for any loss. destruction or deterioration of the goods if the goods are not returned on time.
- In the absence of any contract to the contrary the Bailee is bound to deliver the bailor any increase or profit which may have arisen from the goods bailed.







Rights of Bailee with regards to Goods

- The Bailor is responsible to the Bailee for any loss which the Bailee may sustain because by reason that the Bailor was not entitled to make the bailment or to receive back the goods
- If the bailor has No title to the goods and the Bailee in good faith delivers them to the Bailor or according to the directions of the Bailor the Bailee is not responsible to the owner in respect of such delivery
- If the goods are to be kept or to be carried or to have work done upon them by the Bailee for the Bailor and the Bailee is to receive no remuneration the Bailor shall repay to the bail either necessary expenses incurred by him for the purpose of the bailment







Bailee's Lien


• If the Bailee has rendered any service involving the exercise of labour or skill in respect of the goods bailed to him, he has right to retain such goods until he receives the due remuneration for the services rendered.


