SOCIAL SECTORS IN INDIA – EDUCATION

2.1 UGC (Institutions Deemed to be Universities) Regulations, 2023

Why in News?

• Recently the Union Minister of Education released the UGC (Institutions Deemed to be Universities) Regulations, 2023.

Important Information

- The UGC Act 1956 provides for Central Government to declare any institution other than a University to a status of Institution Deemed to be University as if it were a university within the meaning of Section 2(f).
- The **first set** of Regulations was notified in the **year 2010**, which was revised in 2016 and 2019.
- The new Regulations are built on the **principle of a "light but tight" regulatory framework** envisioned in the **National Education Policy 2020.**
- Salient features of Regulations
- The eligibility criteria to apply for deemed to be university status: is NAAC 'A' grade with at least a 3.01 CGPA for three consecutive cycles or NBA accreditation for two third of eligible programmes for three consecutive cycles or in the top 50 of any specific category of NIRF for the last three years continuously or in top 100 of overall NIRF Ranking for last three years continuously.
- Institution deemed to be University may start new courses or programmes in any field in their existing campus and approved off-campus centres, with the prior approval of its Executive Council.
- Distinct institution category: an institution focusing on teaching and research in unique disciplines and/or addressing the strategic needs of the country or engaged in the preservation of Indian cultural heritage or preservation of the environment or dedicated to Skill Development or dedicated to Sports or languages or any other discipline(s), so determined by the Expert Committee of Commission

- Eligibility to set up off-campus centres: Institutions deemed to be Universities with minimum 'A' grade and above or ranked from 1 to 100 in the "Universities" category of NIRF rankings of the relevant year are.
- Universities under a "distinct category" can apply for off-campuses after five years of their declaration if they are accredited with an A grade or figured in the top 100 in the "universities" category of NIRF.
- Withdrawal of permission given to start new courses or new programmes: Deemed to be Universities with NAAC less than an 'A' grade or ranked more than 100 in the current NIRF ranking and failed to rectify the deficiencies pointed out by UGC.
- University offers different courses which come under the regulatory ambit of different statutory bodies, namely the University Grants Commission, the All India Council of Technical Education, National Medical Council, etc., the **rules and regulations regarding fee structure, number of seats,** etc., **issued by such statutory body concerned shall be applicable.**
- The institution deemed to be University may provide fee concession or scholarships or may allocate seats to meritorious students belonging to socially and economically deprived groups of the society.
- The institutions deemed to be Universities shall **compulsorily create Academic Bank of Credits (ABC)** identities of their students and **upload their credit scores in digital lockers** and ensure that the credit scores are reflected in **ABC portal and adopt Samarth e-Gov**.
- Institutions can offer Twinning Programmes, Joint Degree Programmes, and Dual Degree Programmes in accordance with the provisions stipulated in the regulations concerned.

2.2 cyber shikshaa programme

Why in news?

• Recently Microsoft on signed a memorandum of understanding (MoU) with Directorate General of Training (DGT) to train students regarding cyber security skills.

2.4 Waiver of ISTS charges

Why in News?

- Green Grids Initiative—One Sun One World One Grid (GGI-OSOWOG)

 Proposed by - The Prime Minister of India in 2018

 Launched in - 2021

 Launched by - India, United Kingdom, in partnership with the International Solar Alliance (ISA) and the World Bank Group (WB)

 Aim - to provide power to about 140 countries through a common grid that will ensure the transfer of clean and efficient solar power

 Implementation

 Phase I → Indian grid would be connected to the grids of Middle East, South Asia and South-East Asia to develop a common grid

 Phase II → connect the functional first phase to the pool of renewable resources in Africa Phase III → global interconnection
- Recently, the Ministry of Power has granted **waiver** of Inter-State Transmission System **(ISTS) charges** to **Off-Shore Wind Projects** and extended the **waiver to Green Hydrogen/Green Ammonia.**

Waiver of ISTS charges of off-shore wind power projects

- Complete waiver of ISTS charges for off-shore wind power projects commissioned on or before 31st December, 2032 for a period of 25 years from the date of commissioning of the Project.
- The off-shore projects commissioned from 1st January, 2033 would be given graded ISTS charges.
- Previously, all wind energy projects were provided waiver upto 30.06.2025.
- Now, offshore wind would be treated separately, and waiver to these would granted up to 31st Dec, 2032 with graded transmission charges thereafter.

Period of Commissioning of Offshore Wind Power Projects	Applicable ISTS Charges
01.01.2033 to 31.12.2033	25% of the applicable ISTS charges
01.01.2034 to 31.12.2034	50% of the applicable ISTS charges
01.01.2035 to 31.12.2035	75% of the applicable ISTS charges
From 01.01.2036	100% of the applicable ISTS charges

Waiver of ISTS charges for Green Hydrogen and Green Ammonia projects

• Complete waiver of ISTS charges for a period of 25 years from the date of commissioning of the project, for Green Hydrogen/Green Ammonia production units, using Renewable Energy (commissioned after 8th March 2019), Pumped Storage System or Battery Storage Systems or any hybrid combination of these technologies.



- Projects commissioned on or before 31st December, 2030 shall be eligible for this waiver.
- Applicability of waiver date extended from 30 June 2025 to 31 Dec 2030.
- Projects commissioned after 31st December, 2030 will attract graded transmission charges thereafter.

Period of Commissioning of Green Hydrogen/ Green Ammonia Plants	Applicable ISTS Charges
01.01.2031 to 31.12.2031	25% of the applicable ISTS charges
01.01.2032 to 31.12.2032	50% of the applicable ISTS charges
01.01.2033 to 31.12.2033	75% of the applicable ISTS charges
From 01.01.2034	100% of the applicable ISTS charges

Other Guidelines

- Criteria for availing the complete waiver of ISTS charges for PSP projects has now been linked to the date of award of the project rather than commissioning of the project.
 - It will be applicable in cases where **construction work is awarded on or before 30th June, 2025.**
- ISTS charges on drawl of energy from energy storage projects, which was earlier granted to the project, will henceforth be available for each individual user of such project.
 - The individual user will get this benefit, if **at least 51%** of the energy utilized by the user for charging the storage system is renewable energy,



2.19 National electricity Plan for the period of 2022-32

Why in news?

- Recently The Central Electricity Authority (CEA) has notified the National Electricity Plan (NEP) for the period of 2022-32.
 - This includes the Review of the last five years (2017-22), a detailed plan for the next five years (2022-27) and the prospective plan for the next five years (2027-32).

Important information

- Some important data shared
- According to the NEP document, the projected All India peak electricity demand and electrical energy requirement is 277.2 GW and 1907.8 BU for the year 2026-27 and 366.4 GW and 2473.8 BU for the year 2031-32 as per 20th Electric Power Survey (EPS) Demand projections.
- the likely Installed Capacity for the year 2026-27 is 609,591 MW comprising of 273,038 MW of Conventional capacity (Coal-235,133MW, Gas-24,824MW, Nuclear-13,080MW) and 336,553 MW of Renewable based Capacity (Large Hydro-52,446 MW, Solar-185,566 MW Wind-72,895 MW, Small Hydro-5,200 MW, Biomass-13,000MW, Pump Storage Plants



(PSP projects) -7446MW) along with BESS capacity (Battery Energy Storage System) of 8,680MW/34,720 MWh.

- The likely Installed Capacity for the year 2031-32 is estimated to be 900,422 MW comprising of 304,147 MW of Conventional capacity (Coal-259,643 MW, Gas-24,824MW, Nuclear-19,680MW) and 596,275MW of Renewable based Capacity (Large Hydro-62,178 MW, Solar-364,566MW, Wind-121,895MW, Small Hydro-5450MW, Biomass-15,500 MW, PSP-26,686MW; excluding 5856 MW of likely Hydro based Imports) along with BESS capacity of 47,244MW/236,220MWh.
- Share of non-fossil based capacity is likely to increase to 57.4% by the end of 2026-27 and may likely to further increase to 68.4% by the end of 2031-32 from around 42.5% as on April'2023.
- The average PLF (Plant Load Factor) of the total Installed coal capacity of 235.1 GW is likely to be about 58.4% in 2026-27and that of 259.6 GW of coal based capacity is likely to be about 58.7 % in 2031-32.
- The domestic coal requirement has been estimated to be 866.4 Million Tonnes for the year 2026-27 and 1025.8 Million Tonnes for the year 2031-32 and estimated requirement of 28.9 MT of coal imports for the plants designed to run on imported coal.
- The total **fund requirement** for generation capacity addition for the period **2022-2027** is estimated to be **Rs. 14,54,188 Crores** and for the **period 2027-2032 has been estimated to be Rs. 19,06,406 Crores**.
- The average emission factor is expected to reduce to 0.548 kg CO2/kWh_{net} in the year 2026-27 and to 0.430 kg CO2/kWh_{net} by the end of 2031-32.

- To screen and detect rare diseases early at early stages, which will in turn help in their prevention.
- Key provisions:
- Disease categorization



- Group 1: Disorders amenable to one-time curative treatment.
- Group 2: Those requiring long term or lifelong treatment.
- Group 3: Diseases for which definitive treatment is available but challenges are to make optimal patient selection for benefit, very high cost and lifelong therapy.
- Financial support
- Patients listed **under Group 1** will have the **financial support of up to Rs. 20 lakh** under the umbrella scheme of **Rashtriya Arogya Nidhi**.
- Beneficiaries for such financial assistance would **not be limited to BPL families**, but extended to about **40% of the population**, who are eligible as per norms of Pradhan Mantri Jan Arogya Yojana, for their treatment in Government tertiary hospitals only.
- Centres of Excellence: designating eight health facilities as 'Centres of Excellence' and these will also be provided one-time financial support of up to Rs. 5 crore for up gradation of diagnostics facilities.
- National Registry: A national hospital-based registry of rare diseases will be created.
- Additional information
- What is rare disease?
- a 'rare disease' is defined as a **health condition of low prevalence** that affects a small number of people.
- Example: Lysosomal Storage Disorders (LSD), Pompe disease, cystic fibrosis, muscular dystrophy, spina bifida, haemophilia etc.
- Rashtriya Arogya Nidhi provides for financial assistance to patients, living Below Poverty Line (BPL) and who are suffering from major life-threatening diseases, to receive medical treatment at any of the super specialty Government hospitals / institutes.

2.22 India becomes Net copper importer for fifth year in a row


Why in News?

- Recently India's copper imports witnessed a 15 per cent year-on-year jump in financial year 2022-23
 - As per data, the country imported 2.75 million tonnes of copper, both finished and refined, in financial year 2022-23.
 - ✓ The imports witnessed notable **surge by 15% over** the previous year

Important Information

- Important data shared by Ministry of Commerce and Industry
- The country's copper imports had totalled 2.38 million tonnes and 2.39 million tonnes in fiscal 2021 and fiscal 2022 respectively. The FY23 imports were lower upon comparison with 3.57 million tonnes recorded in FY20.







- From a net exporter of 335,000 tonnes in 2017-18, India became a net importer of copper, first in 2018-19 and the trend remains unaltered till 2021-22.
- Major causes:
- **Domestic copper production fell significantly** from FY2019 onwards as a result of shutdown of the Sterlite Copper plant in Tuticorin.
- **Lower refined production** created a huge deficit in the domestic copper market, resulting in large imports for fifth year in a row.

3.1 Norms for transactions in corporate bonds through RFQ platform

Why in News?

- Recently, the Securities and Exchange Board of India (SEBI) has released Norms for transactions in corporate bonds through Request for Quote (RFQ) platform by stock brokers.
- **Objective:** to increase liquidity on the platform.

Key Guidelines

- **Applicability:** only trades pertaining to proprietary capacity of stock brokers
- Stock brokers must undertake at least 10% of their total secondary market trades by value in corporate bonds in that month by placing quotes through one-to-one (OTO) or one-to-many mode (OTM) on the RFQ platform of stock exchanges from July 1, 2023.
- This value will be increased to **25% from April 2024**.
- Stock brokers will have to consider the trades executed by value through **OTO or OTM mode of RFQ** with respect to the total secondary market trades in corporate bonds, during **the current month and immediately preceding two months on a rolling basis**.

About Request for Quote (RFQ) platform

- Launch Year: 2020
- It is a trade execution platform.
- It is a direct participation model where all participants trade in their own accounts

RECENT DEVELOPMENT IN FINANCIAL SECTOR

3.2 Surety bonds and e-bank guarantees allowed for road contracts

Why in News?

- Recently, the Ministry of Road Transport and Highways (MoRTH) has allowed acceptance of e-bank guarantee and insurance surety bonds as bid security and performance security in standard documents of engineering, procurement, and construction (EPC), hybrid annuity model (HAM) and Build Operate Transfer (BOT) (Toll) projects.
- The Ministry of Finance has agreed to contractors engaged by National Highways Authority of India (NHAI) & National Highways and Infrastructure Development Corporation Limited (NHIDCL) to convert their bank guarantees into insurance surety bonds.
- For all the existing contracts including road development, toll contracts, and ropeways
 the Bank Guarantee (BG) may be replaced by an Insurance Surety Bond.

Additional Information

 In 2022, India's first Surety Bond Insurance product was launched by Bajaj Allianz General Insurance.
